

### Overview

In 2016, Louisiana experienced severe storms and flooding in both March and August, collectively referred to as the 2016 Severe Storms and Flooding. The National Weather Service designated the August flooding event, which dropped an unprecedented 7 trillion gallons of rainwater in south Louisiana, as a “1,000-year” rainfall event. These disasters resulted in 56 of the state’s 64 parishes receiving a federal disaster declaration.

The U.S. Dept. of Housing and Urban Development allocated \$1.7 billion in Community Development Block Grant - Disaster Recovery funding to Louisiana for recovery from the Great Floods of 2016. To address unmet needs caused by the Great Floods, LOCD-DR administered housing, infrastructure and economic development recovery programs.

### Funding

Louisiana received the funds in three separate allocations:

*in October 2016, Continuing Appropriations and Military Constructions, Veterans Affairs and Related Agencies Appropriations Act, 2017*

**\$1.2 billion**

*in December 2016, Further Continuing and Security Assistance Appropriations Act, 2017*

**\$51.4 million**

*in May 2017, Consolidated Appropriations Act, 2017*

LOCD-DR launched the Restore Louisiana Homeowner Assistance Program in mid-2017 in response to the Great Floods of 2016. The program survey period closed on Oct. 1, 2018, and the application period ended on Nov. 16, 2018. All homeowners closed on their grant agreements by July 31, 2019.

The program launched, began processing applications and delivered funding to homeowners faster than any other federally funded homeowner repair program in history.

The program has offered over \$669 million in grant funds to assist more than 17,260 homeowners for repairs, reimbursement of repairs or reconstruction of their homes.

In total, 45,440 applications were processed, 100% of program award determinations have been made, the program has completed 17,175 construction projects and all SBA hardships have been processed.
