

Overview

In 2020, Louisiana was hit by five named storms—including Hurricanes Laura and Delta—breaking the state record for the most strikes in a single season. Shortly thereafter, in 2021, storms hit Louisiana throughout the entire year, with Hurricane Ida striking the state as a Category 4 hurricane, dumping large amounts of rain, bringing 150-mph winds and producing extremely high tides.

The federal government has allocated more than \$3.1 billion in federal Community Development Block Grant Disaster Recovery funds to Louisiana for recovery efforts from the 2020-2021 disasters as part of the Disaster Relief Supplemental Appropriations Act of 2022 and the Continuing Appropriations and Ukraine Supplemental Appropriations Act of 2023.

Funding

Louisiana received the appropriated funds in three separate allocations, totaling:

\$1.05 billion

for Hurricanes Laura and Delta

\$2.1 billion

for Hurricanes Ida and the May 2021 Severe Storms
